THIS WRIT PETITION HAVING COME UP FOR ADMISSION ON 13.05.2020, THE COURT ON THE SAME DAY DELIVERED THE FOLLOWING:

ORDER

These Writ Petitions are filed essentially raising the grievance that a large number of hotels and lodges in the temple town of Guruvayoor have been requisitioned by the District Administration, Thrissur for housing persons who may have to be guarantined for proper management of the Covid-19 (Corona Virus Disease-19) situation. It is the grievance of the petitioners that housing of such a large number of people in the temple town of Guruvayoor, would result in extreme hardship and difficulty not only to the individual owners of lodges and hotels, but also to general population in Guruvayoor. They also allege that a proper protocol has to be put in place for the management of the situation. According to them, large number of people are being brought to the hotels and left there with no proper and effective mechanism for the management of the persons who are required to be quarantined in the hotels and lodges.

- 2. On the other hand, the learned Government Pleader appearing for the District Administration would vehemently contend that there is a proper protocol being followed and the persons to be quarantined will be lodged in the hotels and lodges in question only in accordance with such protocol. When this matter was taken up today in the morning session, I enquired of the Government Pleader as to whether the District Collector would be willing to convene a meeting of representatives of petitioners in both these cases to consider the grievances of the petitioners and for laying down a methodology for lodging persons who are required to be quarantined.
- 3. When the matter is taken up again in the afternoon, the learned Government Pleader submits that the District Collector had already held several meetings and had explained the protocol being put in place for persons who are required to be quarantined. One among the several objections raised appear to be that there are large number of senior citizens who are residing in Guruvayoor and that considering the ground situation in Guruvayoor several of

these lodges and hotels are bunched so close to each other that it would be necessary to determine the number of persons who could be safely quarantined in each of these facilities.

4. Sri.Rajith, the learned counsel appearing for the petitioner in W.P.(C) No.9803 of 2020 would invite my attention to Exts.P6 and P7 therein and states that several of the hotels which have now been requisitioned do not find a place in Exts.P6 and P7 and further that the terms of Ext.P8 Government Order have not been followed by the District Administration while taking over or requisitioning the hotels and lodges in question. In the situation where the Government is fighting a pandemic, it could not be appropriate for this Court to issue any directions which may tend to interfere with the process being undertaken by the Government. But that does not mean that the authorities in question should not consider the grievances raised by the petitioners in these Writ Petitions. If the grievances are genuine, they should rectify the short comings being pointed out by the petitioners to the extent possible.
