Subject- Regarding managing for Darshan of Sri Ram Setu/ Setu Bandh/Nalahin Setu by creating some wall.

Manyavar,

By means of this letter, the Hindu Personal Law Board (hereinafter referred as HPLB), an organisation committed to work for the protection and promotion of Personal Laws and other religious rights of the Hindus, request and pray you to kindly order for construction of a wall at Sri Ram Setu site in the sea for few meters and if possible for few kilometres, so that the bridge which is generally known as

Sri Ram Setu, may come in open for the Darshan of human being and all other living creatures of GOD.

Sir,

We are aware that Ram Setu which has been described as Nalahin Setu in Ramayan written by Maharshi Valmiki and Setu Bandh in Sri Ramcharitmanas written by Goswami Tulsidas Ji, is a very pious for the Hindus. Ramayan, Sri Ramcharitmanas and Purans (Skanda Puran, Vishnu Puran, Agni Puran and Bramha Puran) describe in detail about the importance of having dip in Setu area and it's Darshan.

Apart from its religious importance, this Setu has also saved several part of Southern states of our country from Tsunami as it works as a natural barrier. This is clear from the fact that during last tsunami, Sri Ram Setu acted as the natural barrier preventing the direct devastation of the entire Bharatam coastline south and southwest Nagapattinam but the political leaders ruling the country during 2004 to 2014 were so Anti national and Anti Hindu that they went to the site of Ram Setu to flag of the bulldogger entrusted with work to bulldogged the same. The government of Bharat under the leadership of Antonia Maino Ghandi and Manmohan Singh dared to order for bulldozing of that Ram Setu about which Ram himself says through Sri Ram Charit Manas "Mum Krit Setu Jo Darshan Karahin, So Binu Shram Bhav Sagar Tarhin" which mean that all the persons who will see the Setu got constructed by me, will get the Moksha. Apart from for crossing the sea to kill Rawan and to bring back Maa Sita, Sri Ram Setu was constructed to provide security to Rameshwaram jyotirling as well the southern part of Bharat. This is clear from the fact that from the time immemorial, Rameshwaram city has not faced any tsunami and only so the Shiv Lingam established by Lord Ram at the beach is safe and secure from lacs of the years though the neighbouring areas faced tsunamis again and again. The people who have visited Rameshwaram know that the sea near Rameshwaram looks like some big lake. It is because of this bridge wall created by Lord Ram. As per the Ramayan, firstly the bridge was got constructed and after that the Lingam of Shiv was installed at beach. In case this bridge would not have been constructed, the installation of Lingam of Lord Shiva at beach was of no use as even a high tide would have flushed away the lingam which is made of sand. After the recent tsunami having epicenter in Bali in which several lacs people died, Sri K T Thomas, a retired judge of supreme court commented that in case Sri Ram Setu would not have been there, several part of Kerela would have been heavily effected.

The lady of Rome ruling from Delhi tried to destroy that Rameshwaram city to which Lord Ram termed as "Param Ramya Uttam Yeh Dharni,Mahima Amit Jay Nahin Barani" which mean that this city is very beautiful and the importance of it can not be described in words. By destroying the Setu, her agenda was to destroy Rameshwaram jyotirling whose importance has been described by Lord Ram by saying "Je Rameshwar Darshan Karahin, Te Tanu Taji Mum Lok Sidharihin" and "Jo Gangajal Aani Chadahinhen Te Sayujya Mukti Nar Paehen" meaning thereby that all the persons who will see and pore the gangajal on the lingam installed by me, will go to heaven.

The problem to Rome is that this Setu proves so many things in favour of Sanatan Hindu Dharm which were being otherwise propogated by Christian missionary. This Setu proves all characters of Ramayan including King Dasrath and Janak, Lord Ram, Maa Sita, Laxman, Bharat, Satrughan, Nisad Raj, Kewat, Bhardwaj, Valmiki, Atri, Anusueya, Agust, Bali, Sugreev, Jamvant, Nal, Neel, Hanuman, Angad etc. It also proves the ithenticity of different personalities of Sri Lanka like Ravan, Mandodari, Vibheeshan, Kumbhakaran, Meghnath, Supankha, Khar, Doosan, Trisira etc. Apart from the characters, it also proves the different places mentioned in Ramayan such as Janakpur, Ayodhya, Sringverpur, Prayag, Chitrakoot, Nasik, Kishkindha, Rameshwaram and Lanka etc. It also proves that since the time immemorial the humanity was existing on the soil of Bharat and Sri Lanka and also that we were well cultured and well governed. We were well equipped too, is proved from the fact that we were having planes and missiles and our engeenering was of such high quality that we constructed 32 mile long bridges on sea in only 4 days by the use of tree and stones. The method of construction of the Setu has also been mentioned in Ramayan and Sri Ramcharitmanas. Manas says" Ati Utang Giri Padap Leelahin Lehin Uthay, Aani Dehin Nal Neelahin Rachahin Te Setu Banay". The proof of Ram and Ramayan is unacceptable to Rome and so it planned for the destruction of Sri Ram Setu which was tried to be given effect through her Bhartiya agent Antonia Maino living in Bharat with the fake name of Sonia Ghandi.

The lady from Rome was also having personal grudge against Rameshwaram City as it gave birth to the boy who stopped her from becoming the Prime Minister in May, 2004.She was aggrieved with Dr. A.P.J. Kalam and only so was intending to destroy Sri Ram Setu so that the next tsunami destroys Rameshwaram City which dared to give birth to child Kalam who lateron became the President and inspite of 352 members of Lok Sabha supporting her claim, she was denied the appointment as the Prime Minister. Ram Setu is unbreakable and only so the dredging machines entrusted to destroy the bridge were itself destroyed/ broken. During 10 years of Rome Raj every attempt to destroy Sri Ram Setu was done but it is not breakable and so it still exist and persons who were willing to destroy it, has been politically destroyed. Rome Raj was willing to destroy Sri Ram Setu but its efforts to destroy the same gave universe wide popularity to Lord Ram and the bridge got constructed by Nal and Neel under His Lordships order. When the efforts to destroy it was initiated by Antonia Maino and Manmohan Singh, the world wide protest against this move was done by more than fifty Hindu organisations under the banner of Save Ram Setu Movement. The initiation of process of breaking Sri Ram Setu and it's opposition by Hindu organizations and other right minded people was properly published in by the media. The image of Sri Ram Setu as taken by American Space Agency NASA was also published through which the people worldwide got the information that there exist some bridge between Bharat and Sri Lanka under the sea which was got constructed by king Ram thousands or lacs of years ago. As per NASA/Google, its age is more than seventeen lacs years. Tulsidasji describes this happening as "Bandha Setu Neel Nal naagar, Ram kripa Jas Bhayahu Ujagar." (The emergence of Ram Setu gave popularity to Nal and

Neel, the two engineers who got this bridge constructed under instructions of Lord Ram).

It is indeed good that Sri Nitin Gadkari, the minister given the charge of this department declared in the Parliament that Sri Ram Setu will not be destructed and without destruction of the same, the Setu Samudram Shipping Canal Project (SSSCP) will be completed. Virtually for taking such actions your government was voted to power by the citizens of this country. The Hindus which are the majority community of Bharat felt offended when in the name of creating a canal for movement of the ships to save some time and oil, the Prime Minister Manmohan Singh along with the Congress President Antonia Maino Ghandi and K. Karunanidhi went at the site of Sri Ram Setu and flagged of the dredging machine for its destruction. Being offended by the Anti national and Anti Hindu action of the government, the Hindus residing throughout the world initiated Save Ram Setu movement.

Manyavar,

It is for your records and information that the HPLB was the first organization of the country which organize a seminar on this issue in Lucknow, Ayodhya and Delhi. It was the first organization to file the Public Interest Litigation Petition in high court at Lucknow and Delhi seeking the direction to the government not to demolish Sri Ram Setu. This was the only organization which initiated Sri Ram Setu Darsan Yatra between Ayodhya to Rameshwaram which was intitiated as we were of the view that in case the devotees will start Darsan and Pooja of the Setu, no person or the government will dare to break and destroy it. While going to Rameshwaram by train, we also organised the Akhand Path of Sri Ramcharitmanas in the train itself with the Samput " Mum Krit Setu Je Darsan Karehin Te Benu Shram Bhavsagar Tarihen".

Sir,

The government of Bharat working under your able leadership appears to be committed to bring Ram Raj which is not possible unless the Darshan of Sri Ram Setu is managed by erecting some wall. It is possible as only 4 to 40 feet water is there on the said Setu from start to end. The request is that by the side of the Setu, some wall should be erected so that the bridge may come in open for its Darsan. It will give the way to the people across the world to come to Dhanuskoti (Rameshwaram) for the Darshan of the bridge constructed under the orders of Lord Ram. In case it is done, the common man will able to walk on this bridge for few metres. It will fulfil the desire of crores of persons like me to walk, sit and sleep on the bridge through which Ram along with his army went to Lanka to kill Rawan and to establish Ram Raj.

The government has to take steps for managing the Darshan of Ram Setu as the Darsan of this bridge is the easiest way of getting the Moksha as described in Ramayan and Sri Ramcharitmanas. Apart from it, this step of the government will invite tourists from all over the world. They will come to see that Setu which was got constructed under the orders of Sri Ram by Nal and Neel only in four days by the use of trees and stones and which is still existing from the time immemorial. The religious people will come see it as it is the creation of GOD itself and mere a holy dip in this area and the Darsan of this bridge guarantees Mokshha as per Lord Ram himself. The lovers will come to see it as it is 'Symbol of Love' between Ram and Sita.

Management of Darshan of Nalahin Setu by the government is capable of generating huge funds for the government by use of which it can undertake so many projects which are pending due to shortage of funds. Ram Setu is capable of generating millions of crore dollors to government as people across the world will try to come to ours beloved country to see and walk on GOD made bridge.

Darshan of Sri Ram Setu is the easiest way of 'Mokshha' as guaranteed by GOD Ram himself and so we hope that government will manage its Darsan at the earliest. The start of its Darshan and Pooja is also necessary as after that no Babar, Aurangzeb or Antonia will dare to plan its destruction.
