This petition was tagged with Diary No.10795/2020 (Jerryl Banait vs. Union of India & Anr.). In above view of the matter, we dispose of this petition in terms of the order passed in Writ Petition (C) Diary No.10795/2020.

**Writ Petition(C) No.759/2020**

Heard Shir K.V. Viswanathan, learned senior counsel, Shri Tushar Mehta, learned Solicitor General as well as other counsel.

Learned counsel for the petitioner submits that there are only few issues left since other issues are substantially satisfied by orders passed from time to time. The issue is raised by the writ petitioner with regard to payment of salary to doctors of North Delhi Municipal Corporation. He submits that salaries of the doctors and other health workers are not being paid. We have been informed that Delhi High Court has entertained a suo motu writ petition in which all necessary parties have been joined including

North Delhi Municipal Corporation and several orders have been passed by the Delhi High Court under which amounts have also been released.

As the High Court has already entertained the above issue and several orders having been passed, we are of the view that the issues should be raised in the pending matter before the High Court if there is still any grievance. Liberty is granted with regard to the above.

Shri K.V. Vishwanathan, learned senior counsel has also referred to certain agitation of ASHA Workers, who were not paid salary. We are of the view that this is a separate cause of action which cannot be entertained in this writ petition, the aggrieved may take appropriate remedy available in law.

The writ petition is disposed of accordingly.
