It shall be the sole discretion of the concerned Judicial Officers to decide as to whether a matter shall be taken up through video conferencing or through physical hearing or to be adjourned depending upon the facts & circumstances of each case and the number of cases fixed for physical hearing on a given day.
3. In order to avoid overcrowding, the Under Trial Prisoners(UTPs) shall continue to be produced through Video Conferencing only.
4. Deep cleaning of all the courtrooms, common areas shall be carried out between 12:30PM to 1:30PM and also after 4:00PM daily.
