If a member has cast vote for particular EVEN partially then he/she will not be allowed to view the voting details or vote for the same EVEN again. Please note the following headings of dashboard of e-Voting.

- EVEN – EVEN is unique number for particular voting category/ Vacancy/Post.
- ISIN – Unique code given for particular entity that is availing e-Voting services. SCBA in this case.
- Company Name – Description of the post(s).
- Start date – Defines the start date and start time of voting.
- End date - Defines the end date and end time of voting.
- e-Voting status – This indicates the status of voting for particular EVEN. i.e. vote pending/Voted/Partially Voted.


